The regular Council meeting was called to order.

The agenda was reviewed. A motion was made by Fliss to approve the agenda with the addition of a fireworks permit request. The motion was seconded by Renaas. All voted in favor. None voted against. The motion was carried.

Minutes from the September 8th meeting were reviewed. A motion was made by Meyer to approve the minutes with correction. The motion was seconded by Renaas. All voted in favor. None voted against. The motion was carried.

Kroshe gave an update on the punchlist items. The yards are still being worked on. There will be a new catch basin put on 9th and Haarfarger that will be paid for by Bolton and Menk. The concrete work will be started in the next 3 weeks. The drainage at 3rd and Poplar could be caused by a blockage somewhere downstream.

The American Rescue Plan funds were discussed. There were questions on where the priorities should be. A motion was made by Fliss and seconded by Meyer to engage Ehlers to perform services to do an eligibility assessment for ARPA funds and set a special meeting for the 29th of September to do anything in particular with the Sportsman's Club. All voted in favor. None voted against. The motion was carried.

A letter for a State grant for the fuel system card reader replacement project was reviewed. A motion was made by Fliss and seconded by Hanson to approve sending a letter stating they wish to proceed with the project. All voted in favor. None voted against. The motion was carried.

A discussion on the airport hangar doors that were wrecked in the wind during a storm were discussed. Once there is more information this will be brought back up.
