Request: A Special use permit for placement of a portable 10' x 16' wooden shed adjacent to front sidewalk and waiving setback provisions of Zoning Ordinance 125.

The above entitled matter came to heard before the City of Canby Planning Commission on 12th October, 2022 on petition for Special Use Permit under City of Canby Zoning Ordinance No. 125, for the following described property in City of Canby, Yellow Medicine County, Minnesota: The Northeasterly Seventy-five (NE'ly 75) feet of Lot Eight (8) and the Northeasterly

Seventy-five (NE'ly 75) feet of the Southeasterly one-half (SE'ly 1/2) of Lot Nine (9), Block Thirty-three (33), Fourth (4th) Railroad Addition to Canby, Minnesota. The City of Canby Planning Commission recommended approval of the Special Use Permit with conditions.

IT IS ORDERED that a Special Use Permit be granted upon the following conditions or reasons:

1. Said permit shall be for a period of five (5) years from the date of this order, or upon sale or conveyance of the property to a new owner, whichever be earlier, at which time this order shall terminate and be null a void.
2. Upon termination of this special use permit, the shed shall be either removed from the premises, or moved to a location on the premises that is in compliance with all conditions, setbacks and restrictions as specified in the City of Canby Zoning Ordinance in effect upon termination of this Special Use Permit.
3. No improvements or modifications of the shed shall be permitted during the term of this permit.
4. Any deviations from the conditions or use approved which are not corrected or remedied within the time period specified by the Canby Zoning Administrator will result in the cancellation of the Special Use Permit.
