WHEREAS, as of the date hereof all bonds and obligations to which tax increment from the District have been pledged have been paid in full or defeased and all other costs of the Project have been paid; and,

WHEREAS, the Authority by this resolution to cause the decertification of the District after which all property taxes generated by property within the District will be distributed in the same manner as all other property taxes.

Resolution Identifying "Slum and Blight" Conditions in a targeted area of the City of Canby

WHEREAS the City of Canby is undertaking a program of downtown revitalization and redevelopment, and

WHEREAS the City of Canby has identified a specific area hereinafter referred to as the "Slum and Blight" area in which revitalization activities will occur, and

WHEREAS the Canby City Council has assessed the target area for purposes of the 2025 SCDP Grant application and determined that the area can be characterized as blighted by reason of "dilapidation, obsolescence, overcrowding, faulty arrangement or design, lack of ventilation, light, and sanitary

facilities, excessive land coverage, deleterious land use, or obsolete layout, or any combination of these or other factors, are detrimental to the safety, health, morals, or welfare of the community" in accordance with Minnesota Statute 469.002, Subd. 11. Of the 45 parcels within the target area, 42 of them are occupied by buildings or other improvements. Of the 42 buildings in the target area, 18 of them are structurally substandard and 0 are dilapidated.

FUTHERMORE the Canby City Council has identified deteriorating conditions due to the inability of commercial structures to meet codes, and general deterioration of building exteriors in the downtown area.

NOW THEREFORE BE IT RESOLVED, by the City Council of Canby, Minnesota, that the area identified as the target area in the attached map is characterized by conditions meeting the definition of "Slum and Blight."

Section 3. Notice of Public Hearing

- b. Notice of the hearing must be published in a newspaper of general circulation in the City at least once more than ten days but less than 30 days before the hearing.
- C. The newspaper in which the notice will be published must be one of general interest and readership in the community, and not one of limited subject matter. The newspaper in which the notice will be published must be published at least once per week.

John Meyer was present to discuss a HRA request to allocate future decertified TIF 1-4 district funds towards the development of residential lots on Lexington Avenue and Maple Avenue. Funds for Lexington Avenue extension would allow a 300ft extension of utilities, curb and gutter, and street, which would create five large residential lots. Funds for the Maple Avenue extension would allow a 150ft extension of utilities, curb and gutter, and street, creating four large residential lots. The HRA is requesting this action due to pending sales and multiple inquiries about sites for new home construction. These funds would become available after 12/31/2024. A motion was made by Fliss and seconded by Cram. Kack abstained. All voted in favor. None voted against. The motion was carried.

A contract with Parrot Film Company was reviewed. This contract allows Parrot Film Company the exclusive right to exhibit national cinema screen advertisement, or promotions of a product on the screen of the Theater. A motion was made by Fliss and seconded by Kack to renew the contract which would be a 5-year contract that shall provide a payment of \$1000.00 per year, per screen, at the Theater and paid out quarterly. All voted in favor. None voted against. The motion was carried.

A motion was made by Cram and seconded by Kack to appoint Sara Wollum as an authorized banking signer. All voted in favor. None voted against. The motion was carried.

September vendor transactions were reviewed. A motion was made by Cram and seconded by Fliss to approve the September vendor transactions in the amount of \$283,807.40. All voted in favor. None voted against. The motion was carried.

City Administrator, Bonnie Merritt, had an administrator's report for the council. The council was informed that there was a health insurance increase of 5.20%, the supervisor's union would like to request dates to begin to negotiate, a letter was received by the IBEW union to request to negotiate, and a survey that was sent out by Yellow Medicine County regarding cannabis.
