The regular Council meeting was called to order.

The agenda was reviewed. A motion was made by Fliss and seconded by Kack to approve the agenda as presented. All voted in favor. None voted against. The motion was carried.

The council minutes from the May 6th meeting were reviewed. A motion was made by Fliss and seconded by Cram to approve the May 6th minutes. All voted in favor. None voted against. The motion was carried.

Sheila Krohse and Mitch Virnig with Bolton & Menk were present to discuss the bid tabulation for the Lexington and Maple Ave N project. There was a total of 9 bids that ranged from \$550,947.07 to \$719,597.62 with the low bid submitted by A & C Excavating LLC from Marshall, MN. A motion was made by Cram and seconded by Kack to approve the lowest bid submitted by A & C Excavating LLC. All voted in favor. None voted against. The motion was carried.

Due to the bids coming in over the \$500,000 budget, a motion was made by Fliss and seconded by Kack to approve moving excess funds of \$33,000 from the street department fund to assist in covering expenses along with using \$30,000 from the Small Cities Assistance funds. The additional expenses would come from reserves. All voted in favor. None voted against. The motion was carried.

John Meyer was present to discuss the final phase of the Canby Theater restoration project. This final stage focuses on completing essential exterior restoration elements that will return the theater's Main Street façade to its original historic appearance, in full alignment with the Secretary of the Interior's Standards for the Treatment of Historic Properties. The total estimated

cost of this final phase is \$72,540. There is \$40,000 in the 2025 city budget for this project. A motion was made by Fliss and seconded by Cram to allow John Meyer to move forward with a grant application for this project. All voted in favor. None voted against. The motion was carried.

John Meyer informed the council that TIF 1-4 has officially been closed. A motion was made by Fliss and seconded by Kack to use this excess money to make all bond payments for the \$500,000 General Obligation Improvement Bonds, Series 2025A and to open a debt service fund for the proceeds received for GOIB, Series 2025A. All voted in favor. None voted against. The motion was carried.

Matt Wagner was present to discuss his position as airport manager. After further discussion and reviewing the updated job description, a motion was made by Fliss and seconded by Cram to approve the updated job description and approve a waiver of hangar rent during Matt Wagner's duration of being a city employee. All voted in favor. None voted against. The motion was carried.

Due to Matt Wagner's previous position being a contractual service, a motion was made by Fliss and seconded by Kack to move his salary from contractual services to salaries. All voted in favor. None voted against. The motion was carried.

Resolution 2025-06-03-1 was reviewed. A motion was made by Kack and seconded by Cram to approve Resolution 2025-06-03-1. All voted in favor. None voted against. The motion was carried.
